**DIRECTIONS TO SHOW**

Route I-180 West or East, get off Exit 13 heading toward Rte 405 Hughesville. At 2nd light (Penn St/405 intersection), turn left onto 405 North. Building will be on left in 0.8 miles.

Route I-80 from East or West, take Exit 212 (I-180 West) toward Williamsport, and follow directions above for I-180.

From North (Rte 15), get on I-180 East, see above.

**NOTICE TO EXHIBITORS**

**ENTRY FEE:** \$28.00 (includes \$3.00 AKC Event Service fee & \$.50 AKC Recording Fee) for the first entry of a dog and \$18.00 for each additional entry of the same dog. Rally cannot be used as a second entry.

**OPEN DATE: ENTRIES OPEN August 1, 2018**

**CLOSING DATE** for entries 12:00 NOON, Wednesday, September 26, 2018 or when the numerical limit has been reached if reached before Noon, September 26, 2018 (at Trial Secretary office) after which entries cannot be accepted, cancelled or substituted except as provided for in Chapter 11, Section 6 of the Dog Show Rules. **AKC RECORDING FEE OF 50¢ & an AKC Event Service Fee of \$3.00** will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. If a dog is entered in more than one class in one of these events, the AKC Recording Fee and Service Fee is to be collected on the first entry only. (AKC Rules Applying to Dog Shows, Chapter 11, Section 2). An AKC Recording Fee of \$3.00 will be required for each entry in any Licensed or Member Club Rally Trial. If a dog is entered in more than one class in a Rally event, the AKC Recording Fee is to be collected on each of the entries of that dog. (AKC Rally Regulations, Chapter 1, Section 3). All Recording Fees are paid to the American Kennel Club..

**RETURNED CHECKS & DECLINED CREDIT CARDS** do not constitute a valid entry fee. WDTC will add a \$20.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis.

**ENTRIES RECEIVED WITHOUT FEES** will not be accepted. Telegraph and unsigned entries cannot be accepted. Entries not on official AKC entry forms and photocopies of entry forms without the Agreement and Rules on the reverse side of the Official AKC Entry Form are not acceptable.

**NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.**

**NO REFUND FOR DUPLICATE ENTRIES.** We will make every effort to find all duplicate entries, but if a dog has been processed, no refund will be made.

Refund and Cash award checks are void after 180 days and will NOT be re-issued.

**ERRORS ON ENTRY BLANKS.** Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.

**ENTRY FEES** shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Show Committee. If because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made. **BITCHES IN SEASON.** Since bitches in season are not permitted to compete in Obedience Trials, all but \$5.00 of the entry fee for bitches unable to compete for that reason, will be refunded. To be eligible for such refund the Trial Secretary must be notified by letter postmarked OCT 11, 2018 or earlier, together with a veterinarian's certificate on their letterhead confirming the fact that the bitch is in season.

**CONSULT JUDGING PROGRAM FOR TIME OF JUDGING.** All dogs should arrive 15 minutes before judging time. Judges will not wait for any dog holding up a class. Dogs will be judged in catalog order. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged. The show-giving club have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when requested.

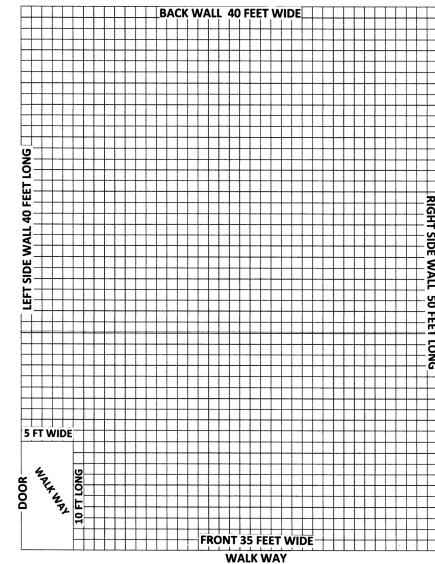

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

INSTRUCTIONS

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name.
